DPW Operations & Finance:

Culvert & Bride Report:

Rattlin Bridge Road: FEMA is readjusting paying 90% of the project. Town and the state will each pay 5% of the project.

Basin Harbor Rd Culvert: Final reimbursement coming.

Middle Road Bridge: Bridge is now open.

Middle Road Culvert: The Town has a copy of the final scoping study.

New Business:

DPW Garage: Efficiency Vermont recommended a heat recovery unit to get rid of the moisture and insulating the attic.

Efficiency Vermont Inspections: The windows in the Town Office need to be sealed and attic needs insulation. The attic currently has vermiculite insulation and may contain asbestos. It will need to be tested before removed.

Fire Station No. 2 East Foundation Wall: There is a crack in the foundation that appears to be from The kind of stone that was used in the cement. Dusty will anchor the wall if needed and get quotes.

Ballot Drop Box: New ballot drop box will be installed at the end of the ramp.

Cellphones/Emails: Discussed personal cell phones and email addresses should not be used for Town business.

Unregistered Dog Warrant: Steve made a motion to send out reminder letters to people who have not registered their dogs. Pierre seconded, motion passed.
